MAY IT PLEASE YOUR HONOUR

The petitioner most respectfully submits as under:

- 1) That he is a permanent resident at the address shown in the title and that his name is shown in the Electoral Roll at Serial No. 1023 at Page No. 25. from Ward No. 44 The petitioner contested from the NCP, a political party from ward No. 44 in the Election for the Mira-Bhayander Municipal Corporation, which was held on 12/8/2007. The Respondent No. 1 has been declared as the returning candidate who had contested as an Independent Candidate in the said election. That the respondent No. 2 to 13 also contested the said election.
- 2) The petitioner submits that he had complied with all the requisitions at the time of filing of his nomination form accompanied by the annexure's declarations and affidavit and therefore his nomination was accepted.
 - 3) The petitioner adds that the said ward No. 44 was an open category. As per the notification published the intending candidates were required to submit their candidature forms between 18/7/2007 to 25/7/2007 before 15:00 hrs. that the scrutiny of the application forms was to be conducted by the respondent No. 15 on 26/7/2007. That the date for withdrawal of nomination form was on and from 27/7/2007 to 30/7/2007 and the final eligible candidates names were declared on 31/7/2007.
 - 4) The potitioner adds that the election for Mira-Bhayander Municipal Corporation were held on 12/8/2007. The results were declared on 13/8/2007 and the Government Gazette was published on 16/08/2007 by the collector of Thane in which the names of elected Corporators are mentioned. It is submitted that the respondent No. 1 has been

shown as elected from ward No. 44. The Respondent No. 1 out of 2584 total voters, secured 939 votes and the petitioner secured 526

- 5) The petitioner adds that the respondent No. 1 who had filed his nomination as an independent andidate for election had submitted his nomination form supported by arious documents which are manifestory required. It is submitted that there were so many important facts which were not disclosed. The form was incomplete. There was suppression of facts. The respondent No. 1 was in arrears in so far as the property tax payable to the Mira-Bhayander Municipal Corporation. Moreover the affective concluded that the scrutiny which was done by the respondent No. 15 was superficial, incorrect or improper and therefore illegal as it was not as per the manifactory requirement. The nomination sight to have been rejected at the scrutiny stage itself.
- 6) The petitioner adds that uncertile state Election Commission order dated 3/7/2002. The nomination form mandatory requirements are clearly mentioned. It categorically states that non furnishing of affidavits, furnishing of any wrong or incomplete information or suppression of any material information may result into rejection of nomination paper. Similarly there is another notification dated 15/3/2006 issued by the state Election Commission which has categorically prescribed the format of affidavit. There is a clear violation on the part of the despondent No. 1 as stated above and therefore the election results in favour of the returning/winning candidate is void and needs to be set aside.
- 7) The petitioner adds that he has all the documentary evidences which are filed along with a separate list filed along with this petition to prove his case. It is submitted that the respondent No. It in his declaration has stated that there are no dues pending to Mira-Bhayander Municipal Corporation against his name. In this respect the petitioner shall prove that the Respondent No. I has not paid his property tax and that the arrears were there. The petitioner adds that there are other properties which in fact are in the name of the Respondent No. I but the same are being suppressed. The said properties details shall be brought with supporting documents at the appropriate stage and for which this petitioner craves leave to produce the same as and when obtained.
- 8) The petitioner adds that the respondent No.1 has corruptly managed to change the electoral voters list. That there are hundreds of names in the final list published by the Municipal Commissioner Mira-Bhayander under his signature who was also the Chief election officer

- for the Municipal Corporation area. It is submitted that hundreds of names of voters were "inserted" by not following the due procedure or without verifying the reality in respect of proof of address etc. It is submitted that all such inserted additional names are also appearing in the other wards Voters list. There are duplication of names of voters in more than one ward.
- 9) It is submitted that as stated above because of the fraudulent insertion of names in the voters list touching the subject matter of dispute the Respondent No. 1 has by illegal means gained from the same for the simple reason that all these voters voted the respondent No. 1. The Petitioner in fact had on coming to know the fraudulent insertion of voters names objected immediately to all the concerned election authorities vide several complaints/letters which were duly acknowledged. The said letters are dated 22/6/07, 25/6/07,5/7/07 and 9/8/07. It is submitted that in the letter dated 22/6/07 there is a specific mention about Buildings like Shital Niketan, Jay Ambe Apartment, Vrindavan and Shubhalaxmi Apartment in which it was fraudulently shown that Voters/ persons are staying but the petitioner specifically pointed out those persons/Voters are not staying still it was overlooked and they were allowed to Vote despite they being not eligible as they were not staying in the said buildings. And such Voters were to the tune of 500 or more which has materially affected the fair election.
- 10) The petitioner dds that on the election day ie. On 12/8/2007 he and his polling agents once again took objections in respect of the inserted "Bogus" Voters in Booth No. 3 but the concerned election officers not only or risoked but went to the extend of getting arrested by the Mira Road Police Station. The Petitioner was illegally detained for about two hours from 9.30 am to 11.30 am by Police officers Viz. Shri Nitin Murade and Shri Manohar Ranmale (even his polling agent was detained in the police station along with the petitioner) and during which time the total control over the election was lost. The respondent No. 1 had managed all this and he saw to it that maximum voting takes place from those of the INSERTED names Voters in the absence of the petitioner while he was detained in the police Station. It is also to be noted that there were no forms kept for taking objections in respect of Bogus Voters.
- 11) The petitioner adds that in view of the facts and circumstances as stated above the results of the election which were held on 13/8/2007 have materially affected due to the improper reception and/or illegal acceptance of the nomination. The respondent no. 1 has committed a fraud. He has not disclosed the true and material facts which were very much within his personal knowledge. By suppressing

and stating false information in his affidevit/ declaration he has committed a serious offence. It is to be noted that the apex court only after finding it necessary has passed an order that the candidates while contesting the elections they should at the time of filing the nomination must file affidavit/s declaring all the factual position on oath in order to preserve the sanctity of the democracy. In the instant the very object has been frustrated. The orders passed by the Hon'ble, Apex Court are violated. The provisions/ principles as laid down under the Act, Election Rules, Notifications/ orders passed by the election commission/s from time to time are all violated and therefore the elections results declared on 13/8/2007 and on 16/8/2007 through the government gazette in favour of the respondent No. 1 are void and/or illegal and needs to be set aside in the interest of justice.

- 12) The cause of action for filing of this petition firstly arose on 22/6/2007 when the objection was taken by the petitioner in respect of the fraudulent Voters list dated 20/6/07 and thereafter it again arosed when again on 25/6/07 the complaint was repeated and this time to all the other authorities. 26/7/2007 when the scrutiny was improper and incorrect. There after it again arose on 31/7/2007 when the eligible candidates list was declared and finally it arose on 16/8/2007 when the notification was published by the collector of Thane declaring the Respondent No. 1 as elected Candidate.
- 13) That the election results were declared on 16/8/2007 when the notification was published by the Collector of Thane and therefore under the Act this petition is filed within limitation i.e. 10 days from the date of publication.
- 14) That the elections which were held were for the Mira-Bhayander Municipal Corporation and therefore this Hon'ble Court has the jurisdiction to try, entertain and dispose of this matter.
- 15) The petitioner therefore prays that:
 - a. It be declared and decreed that the Respondent No. 1 did not comply with the mandatory requirements at the time of filing of Namination forms as per the directions/ notification/ orders issued by the Honble Apex Court, Election Commission.

c. It be further declared and decreed that due to the improper and illegal acceptance of nomination form of Respondent No. 1 the election result has been materially affected and therefore it is void and needs to be set aside.

- d. It be further declared and decreed that the Respondent No. 14 committed illegality and also was instrumental and unfair in allowing the WRONG INSERTION of hundreds of Voters in the Voting list for ward No. 44 who infact were not eligible from the said Ward and whose names were also appearing in the other wards Voters List and on account of which the election result has been materially affected and therefore it is void and needs to be set aside.
- e. The Honble Court be pleased to further declare Petitioner as returning/winning candidate as he has secured Second highest votes in the election dated 13/8/2007 from ward No. 44.
- f. The Hon'ble Court be pleased to disqualify the Respondent No. 1 for becoming a Councillor of any Local Authority for a period of six years.
- g. Pending the hearing and final disposal of this petition the Hon'ble Court be pleased to pass such Ad-Interim/ Interim orders thereby restraining the Respondent No. 1 from acting as Corporator/councillor or taking part as Councillor in the Proceedings/ Meetings of the Municipal Corporation and to exercise his right to vote as Councillor.

h. Any other order in the interest of justice be passed in favour of the petitioner



The results were declared on 13/8/2007 and the Government Gazette was published on 16/08/2007 by the Commissioner of Mira Bhayander in which the names of elected Corporators are mentioned. - e. The Hon'ble Court be pleased to further declare Petitioner as returning/ winning candidate as she has secured Second highest votes in the election dated 13/8/2007 from ward No.27.
- f. The Hon'ble Court be pleased to disqualify the Respondent No. 1 for becoming a Councillor of any Local Authority for a period of six years.





The petitioner most respectfully submits as under

- 1) That he is a permanent resident at the address shown in the title and that his name is shown in the Electoral Roll at Serial No. 1894 at Page No. 42 from ward No. 42. The petitioner contested from the People's Republican Party, a political party from ward No. 73 in the Election for the Mira Bhayander Municipal Corporation, which was held an 12/8/2007. The Respondent No. 1 has been declared as the returning candidate who had contested from Indian National Congress (Congress-I) a political party in the said election. That the respondent No. 2 also contested the said election as an ShivSena candidate. That the Respondent No. 3 was a candidate from Samajwadi political Party for the election held. That the Respondent No. 4 was Returning Officer Shri. J. B. Valvi under whose supervision and control the nomination forms were scrutinised and the entire elections was conducted.
- 2) The petitioner submits that he had complied with all the requisitions at the time of filing of his nomination form accompanied by the annexure's declarations and affidavit and therefore his nomination form was accepted.
- 3) The petitioner adds that the said ward No. 73 was for a reserved category for OBC Category. As per the notification published the intending candidates were required to submit their candidature forms between 18/7/2007 to 25/7/2007 before 15:00 hrs. That the scrutiny of the application forms was to be conducted by the returning officer on 26/7/2007. That the dates for withdrawal of nomination form were on and from 27/7/2007 to 30/7/2007 and the final eligible candidates names were declared on 31/7/2007.
- 4) The petitioner adds that the election for Mira- Bhayander Municipal Corporation was held on 12/8/2007. The results were declared on 13/8/2007 and the Government Gazette was published on 16/08/2007 by the collector of Thane in which the names of elected Corporators are mentioned. It is submitted that the respondent No. 1 has been shown as elected from ward No. 73. The Respondent No. 1 out of 1980 total voters, secured 1045 votes and the petitioner secured 652 votes

therefore the election results in favour of the returning/winning candidate is void and needs to be sex uside.

- 8) The petitioner adds that he has some of the documentary evidences which are filed along with a separate list filed along with this petition to prove his case however the petitioner seeks leave to file such additional documents as and when are available before the hearing. It is submitted that the respondent No. 1 in his declaration has stated that there are no dues pending to Mira-Bhayander Municipal Corporation against his name. In this respect the petitioner shall prove that the Respondent No. 1 has not paid his property tax and that the arrears were there. It is to be noted that at the same time the Respondent no. 1 had not obtained any certificate stating that he does not owe any amount to the Mira-Bhayander Municipal Corporation. Similarly the Respondent No. 1 did not attach any certificate from the Local Police Station declaring that no Criminal Cases are pending against him.
- 9) The petitioner adds that even as far as the caste certificate attached appears to be suspicious, being vague there are two different terminologies used in the documents pertaining to caste declaration.
- 10) The petitioner adds that there are other properties which in fact are in the name of the Respondent No. 1 but the same are being suppressed. The said properties are as follows:
 - a. Motor Vehicle No. MH04 BG 2696, Heavy Goods Vehicle.
 - b. Motor Vehicle No. MH04 BG 2698, Heavy Goods Vahicle.
 - c. Motor Vehicle No. MH04 B 8988, JCB, Escort Make:
- 11) The petitioner adds that in view of the facts and circumstances as stated above the results of the election which were held on 12/8/2007 have materially affected due to the improper reception and/or illegal acceptance of the nomination. The respondent no. 1 has committed a fraud. He has not disclosed all the true and material facts in respect of several properties which were very much within his personal knowledge. By suppressing and stating false information in his affidavit/ declaration he has committed a serious offence. It is to be noted that the apex court only after finding it necessary has passed an order that the candidates while contesting the elections they should at the time of filing the nomination must file affidavit/s declaring all the factual position on oath in order to preserve the sanctity of the democracy. In the instant the very object has been frustrated. The orders passed by the Han'ble Apex Court are violated. The provisions/ principles as laid down under the Act, Election Rules,

4.746.

- 5) The petitioner adds that the respondent No. 1 who had filed his nomination as a candidate for Indian National Congress (Cangress-I) and had submitted his nomination form supported by various documents which are mandatory required. It is submitted that there were so many important facts which were not disclosed. The form was incomplete. There was suppression of facts in respect of several properties both movable in terms of the Actual Number of trucks. dumpers and JCB and also the immovable properties the evidence shall be filed at the appropriate stage and as regards the children particulars and the same shall be proved at the appropriate stage. The respondent No. 1 it is learnt that he was in arrears in so far as the property tax payable to the Mira-Bhayander Municipal Corporation. The Respondent No. 1 have also suppressed the true and actual loan/liability, the ancestral property share etc. there are also suppression of a litigation/case both Civil and Criminal pending against him. There is also a claim pending from the office of the Income Tax/sales tax. The affidavit is also not duly verified i.e. there is signature below the verification clause of the affidavit. But the same has not been countersigned by the returning officer. Moreover the affidavit suffers from falsity due to such and other factors, it can be safely concluded that the scrutiny which was done by the returning officer was superficial, incorrect or improper and therefore illegal as it was not as per the mandatory requirement. The nomination ought to have been rejected at the scripting stage itself.
- 6) The Petitioner here also would like to add that the respondent No. 1 has also given several addresses while registering the vehicles/trucks. This apparently was to avoid or escape the Octroi of the Corporation. It is submitted that registering the several vehicles at different places is allowed only if the said place belongs to him and if it is so then why the said different places/addresses were suppressed. If in the event the Respondent No. 1 does not have any relation towards the said premises/addresses then the only inference could be drawn is he has mislead and played a fraud on the government to escape the Octroi Liability.
- 7) The petitioner adds that under the state Election Commission order dated 3/7/2002. The nomination form mandatory requirements are clearly mentioned. It categorically states that non furnishing of affidavits, furnishing of any wrong or incomplete information or suppression of any material information may result into rejection of nomination paper. Similarly there is another notification dated 15/3/2006 issued by the state Election Commission which has

Pending the hearing and final disposal of this petition the Hon'ble Court be pleased to pass such Ad-Interim/ Interim orders thereby restraining the Respondent No. 1 from acting as Corporator/Councillor or taking part as Councillor in the Proceedings/ Meetings of the Municipal Corporation and to exercise his right to vote as Councillor.


