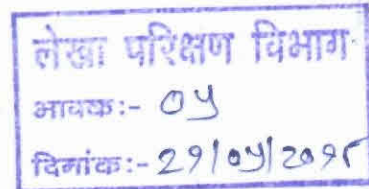

With reference to above subject I would like to inform you

that there has been huge corruption is done by Officers of the Public Works Department of MBMC (Mira - Bhayanader Municipal Corporation). The interested engineers & officer are openly, widely and technicaly doing corruption in the works of Installation of CCTV camera at various schools, hospitals, offices, etc within the jurisdiction of MBMC also to add to the malpractise corruption is also done in maintaining the CCTV cameras.

Before exposing the malpractise I would like you to have a view of CCTV camera quotation given to me from some dealers. The rates given by them were not final and which were negotiable if I ordered. Which means the rates of the items can even become less then specified in the quotation.

(quotation copy at page no 17 & 19)

There has been many schools, hospitals, ward offices , etc and the Head Office of MBMC where CCTV camera has been installed and maintained by MBMC. From the several contracts issued for the said work I have documents of only few works the remaining documents related with the work were not provided by the Public Information Officer of MBMC.

- 3) Installation and commencing of CCTV camera at Tembha Hospital (Pandit Bhimsen Joshi Hospital) of MBMC. (at page no : 55) *2 complete information provided*
- 4) Installation of CCTV camera at various locations of MBMC Head Office building.
(at page no : 79) *2 complete information provided*
- 5) Installation of CCTV camera at Bhayander west rly stn & Balaji Nagar FOB (Foot over bridge). (at page no : 87)
- 6) Installation of CCTV camera at Late. Indira Gandhi Hospital and hospital Premises. (at page no : 97, 99) 103, 105.
- 7) Installation of CCTV at Siddhivinayak Marg (bakery Galli), Bhayander (west).
(at page no : 121)
- 8) Installation of CCTV at Siddhivinayak Marg AND at Police station Bhayander (west) in MBMC area. (at page no : 133)

These above mentioned are the few works done by MBMC.

There are still many more contracts given to contractors for Installing CCTV cameras AND sevrall other contracts for maintenance of CCTV camera but the concerned officers seems not interested in providing information of all works.

When we compare the quotation of other companies and the rates leveied by contractors of MBMC and sanctioned by MBMC officials we find a huge difference between the market rate and the rate leveid by the Municipal contractor.

For example in work no: 1 of Supply, Installation & Commissioning of CCTV work at Chena School in MBMC

we can clearly see the difference in price of every items and it seems that contractor and the interested officer has managed to double the price in some items, in some items the price given is more than market price, in some items it is thrice or 4-5 times of market price, in some itmes the price of the item is multiples by 10 means a product costing 1500 is cahrged 15000 and the bill has also been cleared by MBMC officials. The Fund of Municipal Corporation is the taxpayers money and the same money should be properly utilised.

The Municipal Corporation floats tender so that the corporartion can provide the service to the people at the lowest rate possible.

But this case i.e. Installation of CCTV cameras it looks like the officers of Mira- Bhainder Municipal Corporation are not intersted in giving service at lowest rate, Instead they are More intersted in providing services at a Rate much Higher Rate than the Market Rate .

These proivdes Prima Facie evidence of involvement of MBMC officials and contractors and their nexus in looting the taxpayers money.

Let us take a review of corruption done and the difference in Market Price and MBMC Contract Price.

Below is item wise review of the work for Supply, Installation & Commissioning of CCTV work at Chena School in MBMC. (item estiamte rate at page no: 23, 25)

For item no : 1

The market price for CP Plus Company's 16 channel DVR is between 8500 - 12000 but MBMC contract price is double rs. 24,495 for one quantity.

For item no : 2

The market price for 2 TB Sata HDD HardDrive is between 5500 - 6500 maximum but MBMC price for clearing bill is double ie. rs. 12000 for one quantity.

For item no : 3

The market price for CP Plus Company's 1.3 MP Dome Camera is between rupees 1500 – 2500 maximum but MBMC contract price is ten times the market time ie. rs. 12,500 for one quantity.

The contractor and interested engineer has levied rs 150,000 only for camera.

The total price of 12 camera has been levied on 1 camera by simply adding one zero on rate per item per unit.

For item no : 4

The market price for CP Plus Company's 1.3 MP bullet outdoor Camera is also between 1500 – 2500 maximum but MBMC contract price is ten times the market time ie. rs. 15,500 for one quantity.

The contractor and interested engineer has levied rs 150,000 only for camera.

The total price of 10 camera has been levied on 1 camera by simply adding one zero on rate per item per unit.

For item no : 5

The market price for connector bnc is less than half.

(connector bnc is a plug used for cctv and cable and in wifi one can even see it in our home and office)

These connectors are available at rs. 10-20 also if taken in quantity.

But Mira Bhayander municipal contractor has not even spared such small items.

The connectors are charged rs. 68 means around 70 rs per unit and the total cost levied by MBMC is rs. 4896 i.e. around rs. 5000 only on connectors.

Usually the contractors does not charge any money for the contractors but MBMC officails are not interested in negotiating and finding ways to charge and pay bill for every and every item.

For item no : 6

The market price for 24 inch LCD monitor is higher than the 24 inch LED monitor. One can easily get a 24' inch LED Monitor in less than the price prescribed in the estimate.

Moreover the corporation is paying a price even higher than a LED Monitor to the contractor for LCD monitor.

For item no : 7

Cat 6 cable wire one can easily get such cables around 25-35 rupees per meter but the corporation has levied rs. 84 per meter.

This also includes casing of wire on wall.

If purchased in quantity the cable is easily available at rs. 10-20 per meter.

Here the contract is for 1200 mtr but still the contractor has levied rs. 84 per meter which totals the amount of rs 1,00,800 only for cat6 cable.

Here also the corporation is interested in giving the highest rate possible only to get the highest commission possible from the contractor.

For item no : 8

The PVC 1sqmm is installed free for 10-20 mtrs or more as per negotiations.

Then it is charged rs. 10 or maximum rs.12 for every extra meter required which also includes casing the wire on walls or ceiling.

This is the same cable that the company provided us when we install dish tv or cable tv.

The corporation seems to be less interested in negotiating and has given a price which is triple or four times the market price.

The officers of mira bhayander has given rs. 36.77 per meter which is around rs 44100 for total 1200 mtr.

One can easily get 1200 mtr cable at rs.10 or 12.

That means the total 1200 mtr will cost maximum rs.12000, and if negotiated the same could be easily available below rs. 10.

For item no : 9

The smps is also available at a lower rate ie around 1000 rs but the same is charged as per the maximum price the which the officer can pay to contractors.

For item no 10

It should be checked that any work of false ceiling is done or not.
I doubt that the contractor would have not done any false ceiling work and has cleared the full amount amount of the item without doing any work.

Item no : 11

It should be checked whether the item is used or not.

For item no : 12

The UPS which is a device having some batteries is available at different price range as various companies like Microtech and Luminous and other local or china brand are having low price and cheap quality.

This device is available at price range of 5000, 10000, 20000, and 30000 also
But the price evied by the contractor is obviously higher price and must be a local or china product with cheap quality.

For item no : 13

The rate leveid for 1.5 sqmm is 129 per mtr which is rs. 3228 for only 25 mtr.

The same wire is available at rs 1000 and 1200 for 90 meters.

But the rate of 25 mtr wire used by corporation is higher than 90 meter.

This is many times higher than the market price also as per the above rates anyone can doubt whether copper wire is used or something else.

For item no : 14

The price of local modular switch is rs.10 to 15.

Some good quality switches are available at rs 20-30.

The brands like Gold Medal – GM which are manufacturing high quality switches are available at rs. 30-40.

But the rate of switch of MBMC is rs.84 per unit.

The modular socket are also available at same rate of the switch.

The price of local modular socket is rs.10 to 15.

Some good quality socket are available at rs 20-30.

The brands like Gold Medal – GM which are manufacturing high quality switches are available at rs. 30-40.

Even here the rate of socket which Mira Bhayander Municipal Corporation pays is rs.105 per unit.

The above mentioned items are of only one work done at Chena School in MBMC area.

Work for Various other locations were also awarded.

Since this is the work of installation of CCTV cameras all other works will be having the same items.

There would be difference in number of Units i.e quantity of items.

There has been huge variations in the rates i.e Market price and MBMC price.

Also the price of items are having difference in work to work.

Generally almost all companies like Hik Visison, Cp Plus, Dahua , samsung are having almost same or similar price.

There is hardly any huge variations in price between these companies.

The price that MBMC is far higher than the market price .

Complete Information of all works are NOT PROVIDED like

- 1) Notice Inviting Tender,
- 2) Scope of Work,
- 3) Work Order,
- 4) Copies of Bill and warranty card of all items taken in the estimate,
- 5) Work order and estimate,
- 6) Details of all bidders and sanction of tender committee along with remarks given regarding all bidders who were awarded and rejected.
- 7) Batch number and date of manufacturing of all items included in the estimate.
- 8) Audit report of all works done as per set standards, etc....

NO Information is provided related to Maintenance of CCTV cameras installed at various locations of MBMC .

Moreover there are still many more works of installing CCTV camera and contracts awarded for maintenance of CCTV Camera which the Public Information Officer did not provide .

It is clear that the corporation in the case of CCTV camera contract is floating tender for issuing contract to the contractor who is bidding the highest and gives high rates of every item and over all contract.

It is quite obvious that Engineers, Deputy Commissioner and Officers are clearing bills and awarding contracts with such higher price are being given to contractors in return of some interest. Hence, the involvement of these officers cannot be ignored.

Eventhough the officers know that no self interest should come in the mind of the officers of MBMC because installing and maintenance of CCTV is in the larger public interest and for preventing corruption Sir, it is my humble request to :-

- 1) investigate all the documents mentioned in page no: 7 of each and every work mentioned at page no: 2.
- 2) investiagte all contract and rate awarded for maintenance of these CCTV.
- 3) Investigate other contracts issued for installation of CCTV camera which only MBMC officers know and has not proived the copies due to some self interest.
- 4) investiagte all other contract and rate awarded for maintenance of these CCTV Camera.

Further more it can be clearly seen that a Company named "A-One caretaker Pvt. Ltd" had shown interest in the work of CCTV cameras and had provided the rate much below the rate of MBMC contract awarded.

Rate Copies at page no : 69, 73, 123, 127

There is huge diffence in the rate of items which provided prima facie proof that officers of MBMC are only interested in awarding contracts at high rate.

Moreover along with investigation of all documents related to CCTV work, physical verification regarding the quantity, quality and proper functioning & maintenance of CCTV should be checked on site / location where these CCTV cameras are installed further following instant suspension of the concerned engineer / officer involved in this malpractice with immediate effect and blacklisting of the contractor.

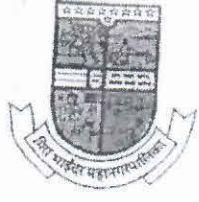
