BRIEF SCOPE OF WORK:

Mira Bhaindar Municipal Corporation has its Head Office Situated at Late. Indira Gandhi Bhavan, Chatrapati Shivaji Maharaj Marg, Bhaindar (West) Dist Thane. The Quotation is called To provide 200 mbps internet leaseline to Mira Bhaindar Municipal Corporation Offices for two years

Eligibility Criteria:

- 1. Scan copy of Emd and form fee.
- 2. The bidder should be a Company registered in India under the Companies Act 1956 or a partnership registered under the India Partnership Act 1932 with their registered office in India
- 3. The bidder should have the offices within Mumbai /thane/ Mumbai Metropolitan Region(MMR).
- 4. GST Registration certificate and Pan Card Copy.
- 5. Average Annual financial turnover during the last 3 years, ending 31st March 2019-20, 2020-21, 2021-22 (financial year) should be at least Rs.3.33 Lacs.
- The bidder shall submit experience certificate from Client for supply, installation of the minimum 100 mbps leaseline in Govt/Semi Govt/ULB office.
- Internet service provider should be connected to nearest National internet Exchange o india(NIXI) Point of presence(POP). (The bidder should submit declaration).

- 8. Bidder should have installation base of 200 mbps internet leaseline circuits in Mumbai, provide documentary evidence of the same.
- Bidder should have minimum Class B ISP, provide certificate for the same Or have Franchise/Distributor Agreement with A/B Class ISP Or Authorization from Class B ISP for supply of Internet.
- Bidder should have its own fiber backbone with auto switch over. Self Declaration certificate.
- 11. The bidder shall not be under a Declaration of Ineligibility for corrupt or fraudulent practices or blacklisted in any Units / Regions / Offices of any Government or Government undertaking Body. Bidder has to submit a declaration in this regard duly signed by the authorized signatory of the bidder.

Terms & Conditions:

- 1. The bidder shall closely peruse all the clauses, specifications and requirements etc., indicated in the Quotation documents, before quoting. Should the bidder have any doubt about the meaning of any portion of the Quotation specifications or find discrepancies or omissions in the specifications or if the Quotation documents are found to be incomplete or require clarifications on any of the technical aspects, scope of work etc., he shall at once contact the officer inviting the Quotations, for clarifications before submission of the Quotation.
- 2. The Quotation should be submitted through offline process of E- Quotationing on www.mbmc.gov.in and offline submitted Quotations will be treated as valid Quotation documents. The rate quoted in offline commercial bid will be treated as valid.
- 3. Bidders are advised to study all the Quotation documents carefully. Any submission of Quotation by the bidder shall be deemed to have been done after careful study and examination of the Quotation documents and with the full understanding of the implications thereof.
- 4. The Quotation submission is offline only. Any bid submitted offline or by post will not be accepted.
- 5. The document fees and the EMD has to be submitted through "Offline Receipt System" available on the e-Quotationing website.
- The price quoted should be the cost which includes all types of taxes applicable Excluding GST.
- 7. The rates must be quoted inclusive of all of all taxes Excluding GST and in Rupees only (No foreign currency will be allowed).
- 8. Income tax and other applicable local taxes will be deducted from the bill submitted after awarding of the Quotation.
- 9. The bill shall be raised the bill after installation. And corporation will do the payment procedure after the bill raised by the successful bidder.

- The successful bidder will be sole responsible for maintain the working of the existing internet Lease line that includes Towers, Devices, Switches and other supportive devices and any permission.
- 11. If required, the successful bidder has to move the existing system from one location to the other free of cost.
- 12. The successful bidder has to submit a system generated report showing the working of the existing network.
- 13. The successful bidder must have to enter into an agreement with Mira Bhaindar Municipal Corporation (MBMC), Bhaindar.
- 14. Hon. Commissioner, MBMC reserves the right to negotiate the rates with the bidders.
- 15. After signing the agreement the successful bidder has to submit a Bank Guarantee of 5% of the value mention in the agreement valid for the duration of the agreement.
- 16. Hon. Commissioner, MBMC reserves the right to accept or reject any Quotation in part or full or cancel the process at any time without assigning any reason thereof.
- 17. In case of any dispute, decision of Hon. Commissioner, MBMC shall be final and binding on all the parties.
- 18. Disputes on a/c of deviation from the terms and conditions are subject to the thane civil courts.
- 19. The successful bidder is expected to maintain the existing Internet lease line up for all the time.
- 20. In case of problem the engineer should reach to the location and make arrangement to start the system within half an Hour.
- 21. Failing which MBMC will apply a penalty of Rs. 500/- per hour.
- 22. The work is Comprehensive, meaning all the required parts are to be provided by the successful bidder.
- 23. The delivery challan and installation report of the same should be submitted at Head office, Computer Department.
- 24. Contractor will have to commence the lease line (Internet) within 8 days from the date of issuing the work order.
- 25. The rates quoted should be inclusive of all taxes, duties, etc. No price escalation will be allowed due to any reason. The offer should be firm without any uncertain liability.
- 26. The bidder is requested to go through the Quotation document before submitting the Quotation offline
- 27. If the bidder withdraws his Quotation before the date of letter informing him about the acceptance of the bidder or the bidder backs out from the work after executing agreement and issue of work order, his earnest money deposit will be forfeited.
- 28. The decision of Commissioner Sir, MBMC about any matter or dispute about the contract will be final and binding on the bidder as well as MBMC.
- 29. Any compensation or sums payable by the bidder to the MBMC, under the terms of this contract will be deducted from his bill / security deposit.

- 30. No Quotation will be considered unless submitted in the prescribed form.
- 31. Conditional Quotations will not be considered.
- 32. Price escalation will be not being admissible on any account whatsoever.
- 33. MBMC reserves the right to terminate the contract any time during execution period if the performance or progress of the work is not found satisfactory.
- 34. If the contractor fails to complete the work in given time, MBMC may terminate his contract after giving him opportunity.
- 35. MUX has to be installed within MBMC premises.
- 36. Internet bandwidth has to be provided by the bidders filtering spyware and viruses at gateway level itself.
- 37. Bandwidth supplied should be in loop to ensure redundancy and maximum uptime.
- 38. As per MBMC requirement bandwidth of lease line will be consider.
- 39. Bidder should provide minimum 15 live IP's or more as per MBMC's requirement for offline applications.
- 40. The Internet connectivity leased line should have fully dedicated (1:1), unshared & High Quality symmetric bandwidth without any compression factor through Optical Fiber.
- 41. The ISP will also be responsible for any civil / electrical work etc. involved for completion of project and obtaining the necessary permission from the respective authorities. MBMC is not responsible for obtaining any such permission.

46. Service Support

The bidder should provide support for trouble shooting on 24X 7 X 365 basis so that the maximum availability of the Internet connectivity is ensured.

Uptime

99% uptime on 24X 7 X 365 basis from MBMC, Mumbai terminal point to ISP location. Deduction shall be made from quarterly charges on pro-data basis for connectivity down time beyond 1% during the quarter.

47. Trouble Shooting:

Bidder shall respond with a solution within an hour of reporting of a problem and restore satisfactory operation within maximum of one hour.

48. Service Performance

The following SLA parameters should be adhered to:

- a. Packet Loss < 1%
- b. Domestic Latency < 70 Millisecond during peak traffic hours
- c. Circuit availability 99% (calculated on quarterly basis)
- d. Average latency should not be more than 350ms up to ISP's 1st Tier 1 peering point
- e. The interface would be an Ethernet.

The bidder should furnish a detailed network/ schematic diagram of total proposed solution showing connectivity from ISP's gateway Terminal Point to MBMC Last Mile connection.

49. Earnest Money Deposit. (EMD)

- The Bidder shall furnish as part of its bid an Earnest Money Deposit of Rs. 17,000/- (Seventeen Thousand only.) through offline Quotationing process.
- γ . The EARNEST MONEY DEPOSIT shall be in Indian Rupees only.
