Without prejudice to my rights and contentions and in further to; I want to bring in your kind of notice that a **SHOW CAUSE NOTICE** shall be issued to **Mrs. Dimple Vinod Mehta Corporator and Mayor of MBMC** on the ground of construction and supporting and misusing power and position for illegal and unauthorized structure violating the provisions of Sections 10(1D), 11 and 12 of the Maharashtra Municipal Corporations Act, 1949 or the Maharashtra Regional and Town Planning Act, 1966.

**Mrs. Dimple Vinod Mehta Corporator and Mayor of MBMC.**

- a) **Mrs. Dimple Vinod Mehta Corporator and Mayor of MBMC, SPOUSE Mr. Vinod Lalchand Mehta** have constructed illegal and unauthorized structure violating the provisions of this Act, 1949 and the Maharashtra Regional and Town Planning Act, 1966. And flouted various CRZ Norms on whom several FIRs have been registered for alleged destruction of mangroves
- b) **Mrs. Dimple Vinod Mehta Corporator and Mayor of MBMC**, being a Councilor and Mayor may have physically, obstructed and tried to obstruct MBMC Encroachment Department and Ward Office 06 & 04 officers and Competent Authority from discharging its official duty in demolishing of illegal and unauthorized structure.

- d) **Mrs. Dimple Vinod Mehta** being a Corporator and Mayor of MBMC and her brother in law **Mr. Narendra Lalchand Mehta (Member of Legislative assembly)** are using illegal structure for commercial purpose.
- e) **Mrs. Dimple Vinod Mehta Corporator and Mayor of MBMC** are using Hoarding & Banners and running commercial business from said illegal structure.
- f) **Mrs. Dimple Vinod Mehta Corporator & Mayor of MBMC** is making huge revenue loss to MBMC.

मीरा रोड येथील कनाकिया भागात सेव्हन इलेक्शन हॉटेल एक पंचतारांकित क्लब उभारत आहे. आमदार नरेंद्र मेहता यांचे बंधू आणि महापौर डिंपल मेहता यांचे पती विनोद मेहता हे सेव्हन इलेक्शन हॉटेलचे संचालक आहेत. क्लबचे बांधकाम करताना करण्यात आलेल्या मातीभरावात कांदळवनाचा नाश झाला असल्याची तसेच सीआरझेडच्या क्षेत्रात कुंपण भिंत बांधण्यात येत असल्याची तक्रार माहिती अधिकार कार्यकर्त्यांनी आणि पर्यावरणवाद्यांनी महसूल विभागाकडे केली होती. या तक्रारीनंतर नवघर तलाठ्यांनी जागेचा पंचनामा केला आणि त्यानंतर तहसीलदारांच्या आदेशानंतर मंडळ अधिकारी लक्ष्मण पवार यांनी विनोद

## सामाजिक कार्यकर्त्यांकडून तीव्र निषेध

गुन्हा दाखल झाल्यानंतर संतप्त झालेले आमदार नरेंद्र मेहता गुरुवारी सायंकाळी उशिरा मीरा रोड पोलीस ठाण्यात दाखल झाले. या प्रकरणात तीन वेळा गुन्हा दाखल झाल्यानंतर पोलिसांकडून कोणतीही कारवाई

झालेली नाही. त्यामुळे एकतर तीन वेळा गुन्हे दाखल केलेल्या विनोद मेहता यांना पोलिसांनी अटक करावी अन्यथा त्यांच्यावर खोटे गुन्हे दाखल केल्याप्रकरणी महसूल विभागाच्या अधिकाऱ्यांवर गुन्हा दाखल करावा, अशी भूमिका मेहता यांनी यावेळी घेतली. या प्रकरणात गुन्हा दाखल झालेले माजी नगरसेवक प्रशांत केळुस्कर यांनी २०१२ मध्येच सेव्हन इलेक्शन हॉटेलच्या संचालकपदाचा राजीनामा दिला आहे. असे असतानाही त्यांच्यावर गुन्हा दाखल केल्याचे मेहता यांचे म्हणणे आहे. महसूल विभागाचे वरिष्ठ अधिकारीही यावेळी पोलीस ठाण्यात उपस्थित होते. या प्रकरणावर रात्री उशिरापर्यंत चर्चा सुरू होती. यानंतर महसूल विभागाच्या अधिकाऱ्यांनी या प्रकरणाची चौकशी करण्याचे आश्वासन दिल्याचे आमदार मेहता यांनी सांगितले.
