Hope4 Best Foundation and Hope4Best Consultant Pvt Ltd**

Respected Sir,

I am writing to bring to your attention a serious concern regarding a tender process for training in the health paramedical sector. Two companies, *Hope4 Best Foundation* and *Hope4Best Consultant Pvt Ltd*, both under the directorship of **Preeti Manbodhan Mishra (DIN number 08690444)**, have filed tenders for providing paramedical training for the following courses:

The course duration is stated as 90 days, and the required qualification for students is SSC.

I would like to raise the following objections:

1. ****Violation of Competition Act 2002****: According to the Competition Act, two companies with the same ownership or director cannot file separate tenders. This action directly violates the principles of fair competition.
2. ****Contradiction with Optometry Council Guidelines****: As per the letter dated 16th May 2019 from the Optometry Council of India, it is explicitly stated that the council does not endorse short-term courses. Therefore, it is questionable how Mira Bhayander Corporation issued a tender or work order for such training that includes an optometry assistant course.
3. ****Lack of Public Application for Training****: The training program is being provided without inviting applications from the public, raising serious concerns about transparency. It appears that the decision on who receives the training is left solely to the discretion of the contractor, which is both unethical and illegal in the medical field.
4. ****Absence of Vigilance Department****: It is concerning that there is no vigilance department within Mira Bhayander Corporation to monitor or investigate such irregularities. This lack of oversight has allowed these questionable practices to take place.

In light of these issues, I request that you kindly ****blacklist both organizations**** and ****cancel the tender process/work order**** immediately. This action is necessary to prevent the misuse of public funds, amounting to Rs 1 crore 20 lakhs.


I hope you will take swift action on this matter.

****Subject: Violation of Competition Act by Hope4 Best Foundation
and Hope4Best Consultant Pvt Ltd****

Respected Sir/Madam,

I am writing to formally lodge a complaint regarding a violation of the Competition Act, 2002, by two companies—*Hope4 Best Foundation* and *Hope4Best Consultant Pvt Ltd*. Both companies are under the directorship of **Ms. Preeti Manbodhan Mishra (DIN number 08690444)**.

These companies have both filed tenders for paramedical sector training under the Mira Bhayander Municipal Corporation, specifically for the following courses:

I believe this action is a direct violation of the Competition Act 2002 for the following reasons:

1. ****Same Ownership, Multiple Tenders****: Both companies share the same director, which creates an unfair advantage. As per the Competition Act, two companies with the same owner or director should not be allowed to file separate tenders in the same process, as it restricts fair competition.
2. ****Illegal Endorsement of Short-Term Courses****: Additionally, the Optometry Council of India has, in its letter dated 16th May 2019, clearly stated that it does not endorse short-term optometry courses. Despite this, one of these companies has managed to secure a work order, raising further concerns about the legitimacy of the tender process.

This situation represents a clear breach of competitive practices and raises concerns about the misuse of public funds. I kindly request the Competition Commission to investigate this matter and take appropriate action, including penalizing the companies involved.

I look forward to your prompt attention to this complaint.
