



Ne believe that this is a violation of the **Competition Act, 2002**, which prohibits anti-competitive Ne Delieve Sike bid-rigging and collusion. Furthermore, it reflects potential corruption and misuse of public fractions which goes against the principles of transparency and fairness required in public tenders

in light of the above, I hereby request you to:

- 1.**Investigate** the tender process in question for any irregularities, collusion, or corrupt practices.
- 2 *Suspend the work orders** issued to the three Bachat Gats until a thorough inquiry is conducted.
- 3. Take **appropriate legal action** against those responsible for manipulating the tender process.
- 4. Ensure **Cransparency and fairness** in all future tenders to uphold the integrity of the Municipal

Itrust that you will take this matter seriously and initiate an investigation at the earliest to protect public interest. Kindly acknowledge receipt of this complaint and keep me informed of the action taken in this regard.
