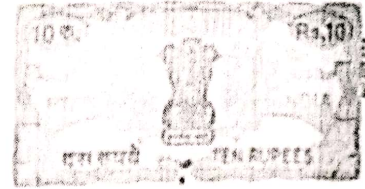

❖ According to RTI law bestows a right to the Citizens and Citizens can exercise his right. The Public Authority has just to make it convenient for the Applicant to inspect.

→ According to RTI, Inspection is not seeking information u/s 6(1) of RTI Act 2005 and one can walk-in in any Public Authority Office and demand his Right to information by inspection under Section 2(j)(1) of RTI Act 2005.

→ Section 2(j) is reproduced below: Section 2(j) "right to information" means the right to information accessible under this Act which is held by or under the control of any public authority and includes the right to-

(i) Inspection of work, documents, records;

(ii) Taking notes, extracts or certified copies of documents or records;

(iii) Taking certified samples of material;

(iv) Obtaining information in the form of diskettes, floppies, tapes, video cassettes or in any other electronic mode or through printouts where such information is stored in a computer or in any other device;

D. Period of Information : 01/01/2022 to till date of RTI reply.

E. Information required :

- Section 2(1)(i) of the Right to Information Act, 2005 gives a right to every citizen to inspect any work carried out by Public Authority in Public places. I wish to inspect the following work.


- i. Please let me know the DATE, TIME AND VENUE when I should come for an inspection to check the working conditions of the EV Charging station.

- I would like to inspect the following documents related to this work at the time of inspection. These records should be made available to me for inspection when I come for inspection of the above work:

- i. Copies of contract copies with contractor for EV Charging, Cost per Unit & DLP & Maintenance Work & Work Orders & Payment Details & Attendance Register & Fault Log Books & Other Audit Books

- ii. Certified copies of licence details of contractor for EV Charging.

- I would like to take photographs of EV Charging Stations switch boards, panels & other electric items in the presence of the Public Authority. If I desire to take copies or samples of any of the above documents or parts thereof or materials, I would intimate the same after inspection. I request that the copies should be provided to me after charging a prescribed fee.
