**AGREEMENT FOR PROVIDING  
SECURITY SERVICES**

THIS AGREEMENT is made at Mumbai on this 31<sup>st</sup> day of month of October, Two Thousand and Twenty Three;

**Between**

Maharashtra State Security Corporation, a Body Corporate constituted under The Maharashtra State Security Corporation Act, 2010, represented by its Director (Induction) having its registered office at Center 1, 32 Floor, World Trade Centre, Cuffe Parade, Mumbai 400 005, hereinafter for brevity referred to as "**MSSC**", (which expression unless repugnant to the context or meaning thereof mean and include its successor or successors, administrators and assigns) of the **ONE PART**;

**AND**

Mira-Bhainder Municipal Corporation, a Body Corporate Constituted under the Maharashtra Municipal Corporation Act, 1949, represented by its Deputy Municipal Commissioner, having its registered office at Late Indira Gandhi Bhavan, Chhatrapati Shivaji Maharaj Marg, Bhainder (West), Dist.Thane, hereinafter for brevity referred to as "**THE CLIENT**" (which expression unless repugnant to the context or meaning thereof shall mean and include its successor or successors, administrators and assigns) of the **OTHER PART**;

**WHEREAS:-**

- (a) **MSSC** is a Statutory Corporation of the Government of Maharashtra established under the Maharashtra State Security Corporation Act, 2010 (hereinafter referred to as "**the Act**") by the State of Maharashtra for the purposes of raising a Security Force for providing better protection and security to the State Government and Central Government offices, undertakings, public sector undertakings, employees of all such establishments, etc. as provided under the Act.
- (b) The **Client** intends to engage **MSSC** for providing security personnel at its location(s). **The list of locations is annexed herewith as Schedule-I.**
- (c) The **Client** appointed its representative(s) to coordinate with the **MSSC** for conducting a Joint Security Audit by the officers of MSSC and the representative(s) of the Client at the Client's said location(s).
- (d) After conducting the said Joint Security Audit of the location(s) by the officers of the **MSSC** and the **Client**, the Security Audit Report of the said location(s) has been prepared, approved and signed by the said Joint Survey nominees for deployment of security personnel at the Client's said location(s).
- (e) Accordingly, **MSSC** has agreed to deploy 250 number of Security Personnel ("**the Security Personnel**") on a contractual basis for a period of **1 year commencing from 15.09.2023 and expiring on 14.09.2024** as per the aforesaid Joint Survey. In case, even after contractual period these services are required further by the Client and the performance of the MSSC is found to be satisfactory, the said period may be further extended by the parties for such period and terms as may be mutually agreed between MSSC and the Client. A chart of the **Security Personnel** to be deployed indicating the number, designation and description of the personnel are annexed as **Annexure "I"** hereto.
- (f) In consideration of the deployment of the aforesaid **Security Personnel** by **MSSC**, the Client has agreed to avail the Security Services of **MSSC** at the said location(s) and whereupon a financial details is attached herewith as **Annexure "II"**.
- (g) The said Security Services by **MSSC** are to be provided in accordance with the provisions of the **said Act and Rules** there-under as may be amended from time to



time and for provisions where of shall remain binding on the parties hereto. The provisions of the said Act and the Rules thereunder are read, understood and accepted by the **Client**.

- (h) The parties hereto have, pursuant to the Agreement arrived at between them, entered into this contract upon the terms and conditions mentioned hereinafter.

**NOW THIS AGREEMENT WITNESSETH as under:-**

1. **MSSC** agrees to deploy 250 number of **Security Personnel** on a contractual basis for the **Client** as per the Joint Survey and the financial proposal submitted by **MSSC** to the **Client** and accepted by the **Client**. The said financial proposal submitted and accepted by the **Client is Annexure "II"** hereto.
2. A re-survey shall be conducted of the said locations at the end of every year or as and when warranted by the corporation. Re-survey may require changes/modifications to the existing strength of the Security Personnel due to any of the factors mentioned below but not limited to:-
  - (a) Deficiency in manpower at duty points;
  - (b) By reason of under assessment when the need based strength was determined;
  - (c) Due to commissioning the new manpower;
  - (d) Coming up of Pedestrian /vehicular/railway gates or change of Security Scenario.
  - (e) Erection of a watch tower;
  - (f) Eventualities which could not be anticipated earlier being new developments; and
  - (g) Needs arising from re-calculation of the manpower requirements for various duties.
3. In addition to mandatory re-survey, if need arises, re-survey can be asked by either of the parties.
4. The initial **period of this contract** will be for **12 months with effect from 15.09.2023 to 14.09.2024** which contract may be further extended by the parties for such period(s) as may be mutually agreed between **MSSC** and the **Client**.



5. The rates offered by **MSSC** and accepted by the **Client** are given at **Annexure "III"** hereto. However, in addition thereto, all applicable taxes and payable to the Government and Statutory Authorities shall be borne and paid by the **Client**. Further, the rates will be governed by various laws then applicable. **The rates will be applicable to the client if raised by BOD of MSSC during the contract period and the clients agree to such revision of rates as and when raised by the Board of Directors of MSSC.**

**The Board of Directors of MSSC in their 19<sup>th</sup> BOD meeting held on 26<sup>th</sup> July, 2023 passed a resolution to hike chargeable rates of MSSC security personnel by Rs. 5000/- in each cadre, The same rate will be applicable from 1<sup>st</sup> Dec. 2023 as shown in Annexure "III".**

6. All the instruments, apparatus, space and other wherewithal necessary for conducting security and administrative duties at the **Client's premises, which includes table + chairs, storeroom for keeping security gadgets, facilities for rest, changing rooms for female personnel, toilets etc.,** will be provided by the Client. It is desired, though not mandatory to provide food and other welfare amenities for the security personnel at the same rate, terms and conditions, as that for Client's own employees. The Client shall provide a suitable control room, if the deployment at any particular location is more than fifty security personnel in three shifts.
7. At the outbreak of epidemic / pandemic disease the Client shall provide to the on duty security guards of MSSC with preventive kits like PPE Kits. N-95 Masks, Sanitizer, Hand Gloves, Face Shield etc.
8. If the duty posts is away from regular mass transit route, transportation shall be provided by the client. Accommodation whether temporary or permanent, shall be arranged by client where the entire deployed manpower is required for attending to exigencies of high alert situations.



9. The **Client** shall authorize and shall vest the security personnel and officers with the requisite powers and authority for the effective discharge of their duties at the said location(s) of deployment.
10. The issues like discipline, conduct etc. is the sole jurisdiction of **MSSC** and **MSSC** shall take immediate and suitable steps to ensure that lapses in discharge of security functions, if any, when brought to its notice, are immediately corrected/removed.

**LOSSES DUE TO THEFT/PILFERAGE/ DAMAGE:**

11. **MSSC** shall take all reasonable steps to ensure that no theft, pilferage or untoward incidents take place in the area or installation under the charge of its security personnel. In the case of any such untoward incidence, **representatives of the Client shall register FIR with the local police station.** **MSSC** will cooperate the case towards its logical conclusion.
12. In the case of such loss/theft, **MSSC** shall conduct enquiry against its personnel and take necessary disciplinary action and corrective measures. However, **MSSC** shall not be liable and cannot indemnify the client for the loss arising out of acts of theft, pilferages, arson or damages.

13. **PROCEDURE FOR PAYMENT OF BILLS:-**

- (a) Payments shall be made by the **Client to MSSC** on a monthly basis. It is agreed between **MSSC** and client that no deduction of whatsoever in nature viz. vigilance charge, labour cess and etc. shall be deducted from the said monthly bill.
- (b) In order to get reimbursement of the expenditure on the Recovery Bill, consolidated bill in duplicate shall be raised by **MSSC** upon the **Client** for each concluded month during the second week of every current month. Upon receipt of such bill, the **Client** shall remit payment thereof within 15 days from the date of receipt of the bill by Cheque/DD/PO/RTGS/Electronic Transfer to **MSSC**.
- (c) Client should provide the details of monthly payment advice / any other payments with UTR/Reference No. by email or letter to **MSSC**, once the payment is transferred by NEFT or RTGS.
- (d) Client shall provide copy of ledger details every quarter to reconcile it with **MSSC**

- (e) The client shall provide Form No.16A (TDS Certificate) quarterly to MSSC.
- (f) It is agreed between the parties that in case there is delay on part of the Client in releasing the payment **in excess of two months from the date of receipt of bill raised by MSSC**, the interest at the rate of 12% per annum shall be payable by the Client from the date of expiry of such period of three months. Thereafter, MSSC shall initiate withdrawal procedure of its security personnel from the client's establishment without any prior notice and the Security Deposit amount and advance payment will be adjusted against the pending bills.
- (g) Regular weekly off and government authorized holiday shall be provided by the client to the security personnel deployed as per the provisions of The Bombay Shops & Establishments Act, 1948 and MSSC shall provide casual and earned leave to its security personnel. The Security personnel can avail casual and earned leave along with weekly off.
- (h) In view of paragraph 13 (g) hereinabove, a provision of 28% buffer over and above the deployment is made in the mutually agreed deployment for the **Client**. As such, for an actual on-field deployment of **SSO (Rtd.ACP) 1, SSO (Rtd.PI/API) 3, HG 5, ASG 3, SG 156 & LSG 28** in three shifts in a day, **SSO (Rtd. ACP) 1, SSO(Rtd. PI/API) 4, HG 6, ASG 4, SG 199 & LSG 36** are actually provided as shown in columns II, III, & IV of the Tables 13.1 to 13.4 below.
- (i) 28% buffer is shown in the column III of payment shall computed on total number of security personnel provided for duty in three shifts per day - for a month - on man-days basis in the column IV . The MSSC personnel will work in the three shifts. Billing will be charged in the column IV as shown in tables 13.1 to 13.4 here below

- (j) MSSC shall charge 28% buffer cost for leave & other benefits on the actual cost of man-days as indicated above column IV. If there is 100% attendance on duty as per column II above, then maximum charge as per column VII would be levied by loading the 28% buffer as shown in column VI.

In case of shortfall in attendance in column IV, MSSC shall charge on actual attendance basis (including 28%). The maximum monthly charge would be Rs 59,13,000 /- (Old Rate) & Rs.71,63,000/- (New Rate).

- (k) The deployment of manpower shall be in the limitation of all the prevailing laws and rules made by the government from time to time.



- (l) In the normal circumstances duty hours for security personnel shall not exceed 8 hours. However, if extra duty hours are to be made available as per the specific request of the **Client**, it shall be charged @ double of the normal rate as per section 14 of the Minimum Wages Act 1948.

**14. ADVANCE SECURITY DEPOSIT:**

The **Client** has deposited with **MSSC** **three months' security deposit (without GST & refundable) Rs.1,77,39,000/-** [One Corer Seventy Seven Lakhs and Thirty Nine Thousands only] for deployment by **MSSC** of security personnel as interest free security deposit. **MSSC** shall not accept Bank Guarantee towards the said Security Deposit. The said interest free security deposit shall be refunded by **MSSC** to the **Client** after full & final settlement with the consent of both the parties. The said Security Deposit amount and advance payment will be adjusted against the pending bill.

15. All Government taxes whatever on the billed amount at the rates prevailing from time to time, shall be borne and paid by the **Client** and which shall be in addition to the liability to pay the billed amount.
16. **MSSC** alone shall be responsible to settle the legal dues of its Security Personnel on termination of their services by **MSSC** and no liability will rest upon the **Client**.
17. **MSSC** shall return all materials, equipment etc. provided by the **Client** to its **Security Personnel** upon the completion/termination of this Contract.
18. (a) **MSSC** agrees that it shall maintain all such records and registers that are required to be maintained as per the law, in respect of its personnel deployed under this Agreement.
- (b) An attendance register of security personnel shall be kept by **MSSC** as well as by the **Client** and between the last 5 days of every month, the same shall be reconciled by the officers of the client with the officers of **MSSC** and by the end of each month, the same will be reconciled to avoid any differences or variations in the invoices to be raised by **MSSC**



19. In case of breach or for any valid reason, this Agreement may be terminated by either party at any time by giving 3 (three) months prior written Notice.

**20. CONFIDENTIALITY:**

No party shall disclose any information to any third party concerning the matter of this Agreement. Any proprietary information viz pipeline layout, production/storage, to be contained in reports or disclosed by one party to other party and all the information shall be kept strictly confidential by the receiving party, and shall not be disclosed to any third party without prior written consent of the original disclosing party.

**21. GENERAL CLAUSES :**

- (a) No delay in enforcing any right of a party under this Agreement shall constitute a waiver of such rights, or an acquiescence in the event giving rise to such rights and any such rights may be exercised at any time or from time to time, as the party to whom such rights belong deems fit and proper.
- (b) It is understood between the parties that services provided by **MSSC** to the **client** organization are purely on contract basis, and personnel thus provided shall always remain employees of **MSSC**.
- (c) This Agreement shall (a) supersede and take the place of all prior written and oral understandings and agreements, if any, between the parties hereto with respect to the subject matter hereof and (b) shall not be modified, altered or amended in any manner whatsoever except by an agreement in writing signed and executed by both the parties hereto in which this Agreement is expressly referred to.
- (d) The terms and provisions of this Agreement are severable and in the event that any term or condition hereof is found to be unenforceable by a court of law or otherwise, then all other provisions of this Agreement not found unenforceable shall remain in full force and effect.
- (e) In the present agreement, **MSSC** and the **Client** are collectively referred to as "**the Parties**" and individually as "**the Party**".


**22. DISPUTES AND APPLICABLE LAWS:**

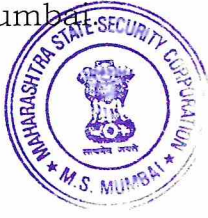
- (a) This Agreement shall be governed by the existing laws of the land.



- (b) In case of any disputes and/or differences, only parties hereto will be entitled to mutually settle the same. No third Party will be involved in the same.
- (c) This Contract/Agreement is subject to jurisdiction of Mumbai Courts alone.
- d) MSSC shall bear the expenses of requisite stamp duty on the present agreement required as per Maharashtra Stamp Duty Act.
