Despite Continuous follow ups with PWD Department and infact taking out a permission personally from RTO for speed Breakers 8 months back , Speed Breakers are not installed on Siddhivinayak Marg sighting non availability of funds or giving excuses of rumblers cannot be put sighting IRC guidelines whereas rumblers have been put on various new places including opposite Porwal school and on 90 feet road, there have been 4 accidents on Siddhivinayak marg where there have been injuries to people due to rash driving by vehicles and can lead to chain snatchings again thus **this makes this a matter of life and liberty where there can be loss of life of people due to speed breakers not put by PWD Department.**
