• You shall provide the information in whatever format you have maintained (it will expose the deficiency in service and willful act of omission) and shall be used as concrete evidence for criminal prosecution. Section 7(9) RTI act

- Information shall be provided in chart form by reproducing the information sought with index and paging, which shall facilitate easy disposal of First appeal and appeal. Section 4(1) (a) RTI act and SIC guidelines page 7 para 7.
- The PIO / FAA shall also give explanation whether the information sought by the applicant shall be denied by him to Legislature / Parliament, in event, if Information is denied. Section 19(5) and section 8 J, RTI act.
- The information cannot be denied on the grounds of 7(9) as these are basic inputs which need to be maintained. The PIO shall explain how providing information shall divert resources. This will be offence of not maintaining proper records punishable under public records act. Section 4(1) A RTI act
- Refer section 2F RTI act, "any information in any form"

There is no restriction in RTI act with regards to subject.

- No information shall be denied quoting section 2F RTI act. PIO Shall be liable for prosecution u/s 18 RTI act. (GAD circular 2009/ P.K.73/ GAD Mantralay dt. 10.8.2009 para 3and para no. 2 GAD circular dt. 31.3.2008.
- You cannot demand CTS no. Citizens cannot be asked to provide CTS number (refer section 4 (1) (a) RTI act).

"Maintain all its record duly cataloged and indexed in a manner and the form which facilitates the right to information under this act"

- The information can be denied only under section 8 of RTI act and no other grounds. (GAD circular 2009/ P.K.73/ GAD Mantralay dt. 10.8.2009 para 3and para no. 2 GAD circular dt. 31.3.2008)
- Illegal / wrongful denial of information other than section 8 is disobedience of direction of law and punishable u/s 166, 217 of IPC.
- There is no provision under RTI act to deny information on grounds of application for one subject. This is framing of incorrect records punishable u/s 167, 218 IPC.
- Denial of information shall be supported by explanation. The onus of proving the correctness of denial is on PIO. Refer section 19(5) RTI act.
- Section 7(9) RTI act

"any information shall ordinarily be provided in the form in which it is sought"

- If any of the above provision of law is violated a complaint can be directly filed u/s 18 RTI which mandatorily directs the Information Commissioner shall that the fine of Rs 250 per day or 25000/- maximum can be levied and shall direct disciplinary action against the PIO.
- See SIC web site for duties of PIO and FAA as prescribed by State Information Commissioner.
- In Fist appeal the FAA shall recommend action against the PIO for denying information wrongfully and violating the provision of section 7(1) RTI act. (GAD circular 2009/ P.K.73/ GAD Mantralay dt. 10.8.2009 para 8.
- The penalty levied u/s 20(1), and disciplinary action taken u/s 20(2) RTI act shall be recorded in the confidential report and service book of the PIO. (GAD circular 2009/ P.K.73/ GAD Mantralay dt. 10.8.2009 para 8.
- FAA shall be responsible for departmental action if he does not take all steps to provide information which is wrongfully denied by PIO. GAD circular dt. 25.6.2019.
- FAA along with PIO shall be liable for **prosecution u/s 166, 167, 217, 218 IPC** if they violate / disobey the above mandatory duties.
