It is revealed during various site visits, that in the subject plot of land belonging to Creado family members, there are many constructions and many busines units are being run therein, although the owners, who got back on 03.10.10 land acuired by ULC authority and also got it surveyed by TILR in 2013, never applied for, and obtained construction permission. It is obvious that some criminal elements have made the constructions illegally and the municiapl authorities, concerned Ward officers, Town Planning department, Encrachment & Illegal Constructions Control department, Property Tax department, signly or jointly have neglected to take action against these illegal constructions and crimnal action against the persons who made these illegal constructions under MPMA, 1949 and MRTP, 1966.
