The Tax payer of this city and country has written more than enough letters to you as mentioned above in the reference, for amendment of Government Circular "to upload RTI applications, their replies and Appeal orders on the website of Mira Bhayandar Municipal Corporation." I had written letter to Thane Anti Corruption Bureau but they had transferred the letter to you to take appropriate action but you forwarded the same to the Commissioner - Shri Madhav Kusekar. Shri Kusekar did nothing just gave order to the Commissioner to publish all RTI applications, their replies and Appeal orders on the website of MBMC, I kept him urging that the officers are corrupt and to submit letter to Thane ACB. But, unfortunately what was his personal interest I was unable to understand as he closed the issue on date : 12/07/2018. And when I submitted letter to go on along with my volunteers then Dy. Commissioner - Shri Vijaykumar Mhasal issued a circular order to all departments to publish all RTI applications, their replies and Appeal orders on website till 20/07/2018 or else Departmental action will be taken on the department who will not follow the same.

At Sir, by seeing throughout scenario of my follow-up since 07 months, it's making a clear sense that both the above mentioned officers (Shri Kusekar, Shri Mhasal and OD of GAD) have received some monetary capital benefits to delay this process so that the corruption which has occurred on name of RTI since many years can be hidden for more time.

I request you to take action on the HOD of departments who have not published the RTI replies and Appeal orders on the website of MBMC yet. The list of departments received from Shri Rajkumar Gharat (Computer Dept) whose RTI's are not there on website is enclosed with this Letter.
