

In case of any modifications to such status in future, such boundary and buffer shall automatically stand modified as per the latest notification. 5. The alignment of Metro, Coastal Road marked on plan are indicative & automatically stand modified by the notification issued by Government from time to time.

6. The alignment of nallah / river / creek is indicative and as per the feature extracted from Drone Imagery and data collected. 7. The boundaries of all the designated sites, Government property are shown as per the image captured by superimposition on cadastral map.
