

**INVITATION FOR BIDS
UNDER
LOCAL COMPETITIVE BIDDING (LCB) PROCEDURES**

1. THE COMMISSIONER, Mira Bhayandar Municipal Corporation, Mira Bhayandar (“the Employer”), invites sealed bids from prequalified eligible bidders for design-build and completion, including ten (10) years operation and maintenance, of the **Underground Sewerage Scheme for MBMC** (hereinafter referred to as “the Works”). The project is proposed to be implemented under Jawaharlal Nehru National Urban Renewal Mission. Mira Bhayandar falls under the Mumbai urban Agglomeration, which qualifies for central assistance of 35% & State Govt. assistance 15% of the total approved project cost. The balance 50% funding plus non funded components under JnNURM shall be arranged through loan from MMRDA / Financial Institutions apart from MBMC’s OWN funds. The works as briefly described below.

Type of Work	Description of Works
Part :1 Sewerage collection and conveyance system	i. Supply and installation of 89 Kms of Np-4 & NP-3 RCC pipes having diameters ranging from 150 mm to 1200 mm and RCC manholes having depths ranging 1.5m to 9 meters along with the allied items & works.
Part 2: STPs& Pumping Stations	i. Construction of 10 nos. of packaged sewage treatment plant of capacity Ranging from 7 Mld to 17 Mld, total capacity of 110 Mld. ii. Construction of 10 nos. of sewage pumping stations in each respective zones.
Part 3: Out falls	i. Supply and installation of outfalls of GRP, diameter ranging from 400 m to 600 mm, total length about 5 Km for disposal and reuse of treated water.
Part 4: Misc. Items	i. Shifting of utilities works ,Implementation of Centralise SCADA along with equipment like computers, scanners, plotters etc, Implementation of Environment Management, construction of Security Guard Rooms, Meter Rooms, Compound walls, etc. around STPs.

3. A complete set of bidding documents may be purchased by interested shortlisted bidders on submission of a written application to the above office, and upon payment of a nonrefundable fee of Indian Rupees 50,000/- (Fifty thousand only). Interested bidders may purchase the documents during all normal working days from 11 am to 4 pm from October 23,2008 to November 20,2008.
4. A three-envelope Local Competitive Bidding (LCB) procedure will be adopted. Bidders are to submit simultaneously two sealed envelopes, one containing the technical proposal and one containing the price proposal. Initially only the technical proposals are opened. Technical proposals which are not substantially responsive are rejected. The substantially responsive technical proposals which have been submitted by shortlisted bidders are discussed with the bidders and bidders are requested to adjust their proposals to reflect the changes and amendments requested by the Employer. The bidders are further requested to submit

supplementary price proposals which contain the changes in price resulting from the discussed changes in technical proposals. The original price proposal and the supplementary price proposal are opened simultaneously in public.

5. All bids must be accompanied by a bid security of **Indian Rupees 2,50,00,000 (Rupees two crores fifty lacs only)** and sealed bids must be delivered to the address given in Sub-Clause 2 above at or before **15:00 hours on 2 December 2008**. Bid securities shall be in the form of a bank draft or pay order of a nationalize bank in favor of the Mira Bhayandar Municipal Corporation, **The bid security must be included with the Technical Proposal**.
6. The Technical Proposals will be opened at **11:00 hours on 3rd December 2008** in the presence of bidders' representatives who choose to attend. In the event of the specified date of the bid opening being declared a holiday for the Employer, the bids shall be received and opened at the same time and place on the next working day.
7. Bids delivered after the time and date noted above will be declared "LATE" and Late Bids shall be rejected.
8. The Price Proposals and Supplementary Price Proposals, if provided, will be opened in the presence of the bidder's representatives who choose to attend at the time and date and at the address to be advised by the Employer after approval of the evaluation committee of the technical proposals.
9. The Employer will not be responsible for any costs or expenses incurred by Bidders in connection with preparation or delivery of Bids.
10. The Employer reserves the right to accept any bid, or reject any or all bids, without assigning any reason thereof and without thereby incurring any liability to the Bidder or Bidders.
11. Bidders are informed that the Employer will conduct a pre-bid meetings at the address given in Sub-Clause 2 above ,which at **11:00 hours on 18 November 2008 at GCC Club, Hutkesh, Kashi Mira Road, and Bhayandar (E)**,will be to clarify issues and answer questions on any matters that may be raised at that stage, or at any stage prior to the pre-bid meeting. Non-attendance at the pre-bid meetings will not be a cause for disqualification of a bidder, but **senior representatives of the bidders are strongly encouraged to participate in the pre-bid meetings** to help ensure that they fully understand the key concerns of the Employer and the employer's Requirements.
